#### 3. E-seal qualified digital certificate

E-SEAL QUALIFIED DIGITAL CERTIFICATE is similar to an electronic signature, with the difference that the signatory is not a natural person with a name and surname, but a legal entity as a whole. A qualified electronic stamp with one pair of keys is used for secure electronic stamping, encryption and access control.

WEB AUTHENTICATION CERTIFICATE is used to certify the public keys of users and organizations that have a valid web address. The server key is used to encrypt a single symmetric session key, which then secures all communication between the server and the client.
